## WHAT DOES NEVADA WEST FINANCIAL DO WITH YOUR PERSONAL INFORMATION?

#### WHY?

Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  • Nonaffiliated companies include companies and dealerships that have a contractual relationship with Nevada West Financial and/or its affiliates.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products and services to you.
